H.R. 2483, SUPPORT for Patients and Communities Reauthorization Act of 2025		
Reauthorizes parts of the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment (SUPPORT) for Patients and Communities Act, including public health programs focused on prevention, treatment, and recovery for patients with substance use disorder.

SUPPORT2025- FCD-AMD_11	Rep. Kelly	Requires the Secretary to halt all DOGE efforts to reorganize SAMHSA until Congress authorizes reorganization.
support2025-fcd-amd_14	Rep. Castor	Requires the Secretary to halt all efforts to eliminate programs reauthorized by SUPPORT.
H2483-AMD_01	Rep. Fletcher	Prohibits HHS from reducing eligibility, reducing enrollment, reducing covered benefits, increasing costsharing, or reducing federal funding for people eligible for Medicaid or CHIP.
TRAHAN_011	Rep. Trahan	Prohibits HHS from reducing eligibility, reducing enrollment, or reducing benefits for people with substance use disorders or mental health conditions who are eligible for Medicaid or CHIP.
H2483-AMD_03	Rep. Ocasio- Cortez	Requires HHS to examine the impact on coverage, access to care, and health outcomes among pregnant women, parents, and infants if Medicaid expansion funding to states is reduced, and/or enrollment of such individuals decreases following changes to federal requirements that make it more difficult for such individuals to enroll in and maintain Medicaid coverage.

09.BARRAG_017	Rep. Barragan	Inserts HR 2004, Tyler's Law, which directs HHS to study fentanyl testing rates in hospital emergency departments and provide hospitals with recommendations on implementing routine fentanyl testing.

## H.R. 1520, Charlotte Woodward Organ Transplantation Discrimination Prevention Act

Prohibits public health care providers and other entities from denying or restricting an individual's access to organ transplants solely on the basis of the individual's disability, except in limited circumstances.

HR1520_01	Rep. Schrier	Adds a sense of Congress to maintain access to vaccinations for immunocompromised individuals, like those who receive organ transplants, who are at a higher risk of infection from vaccine preventable diseases (e.g. measles).
H1520-AMD_01	Rep. Carter (LA)	Prohibits HHS from reducing eligibility, reducing enrollment, reducing covered benefits, increasing costsharing, or reducing federal funding for Medicaid for people with disabilities.
H1520-FCD- AMD_03	Rep. Carter (LA)	Adds a Sense of Congress to maintain access to medical care for immunocompromised children.

# H.R. 2319, Women and Lung Cancer Research and Preventive Services Act

This bill requires HHS to conduct an interagency review on the status of, and identify research related to, women and underserved populations with lung cancer.

HR2319_01	Rep. Matsui	Requires, as part of the HHS interagency report, an assessment of NIH's Indirect Cost (IDC) rate cut on the ability of NIH to carry out the designated activities.
H2319-AMD_01	Rep. Barragan	Requires interagency review to assess the impact of Medicaid coverage on health and mortality outcomes for people with cancer, including access to clinical trials.

# H.R. 1669, To amend the Public Health Service Act to reauthorize the Stop, Observe, Ask, and Respond to Health and Wellness Training Program

This bill reauthorizes the Stop, Observe, and Respond (SOAR) to Health and Wellness Training Program, which provides resources to help build capacity in local communities to identify and respond to the various needs of individuals who have experienced trafficking.

### H.R. 1082, Shandra Eisenga Human Cell and Tissue Product Safety Act

This bill requires HHS to conduct a national education campaign to increase public and health care provider awareness regarding the potential risks and benefits of human cell and tissue product transplants. It would also direct FDA to take additional steps to streamline regulatory oversight of human cell and tissue products.

#### H.R. 2484, Seniors' Access to Critical Medications Act

This bill amends the physician self-referral law to permit Medicare patients to receive prescription drugs through caregivers picking up drugs on the patient's behalf, through the mail, or by couriers delivering the drug to the patient. Limits the policy to 5 years and requires patients subject to this exemption to have an ongoing relationship with the provider and a face-to-face encounter with the provider annually.

HARSHB_002- AMD_01	Rep. DeGette	Prohibits DOGE staff from accessing Medicare data from payment systems.
HARSHB_002- PBM_01	Rep. Landsman	Inserts at the end the bipartisan, bicameral agreement to "delink" the fees retained by Pharmacy Benefit Managers (PBMs) from the price of prescription drugs covered under the Medicare Part D program. Also inserts additional Part D PBM transparency provisions so beneficiaries and Part D plans can have better information related to PBMs.
