2011 Legislative Session in Review

The Colorado AFL-CIO is the largest advocacy organization for working families in Colorado. Our federation represents 181 local union affiliates and over 310,000 active, retired and family members of Colorado's union households – making us one of the largest advocacy organizations in the state.

2011 marked a year of unprecedented attacks across the nation on the rights of workers to have a voice on the job through choosing to form a union. There were many broader attacks on the valuable public servants who provide critical public services, who teach our children and those who care for the sick and elderly. Colorado was not immune to these attacks, but as a result of strong leadership in the Colorado State Senate every single one of these direct attacks was thwarted. Colorado common sense prevailed.

In January 2011, The Colorado AFL-CIO unveiled its pro-active agenda called "Reinvest in Colorado." This agenda sought to promote the utilization of public resources to incentivize hiring Colorado workers and encouraging tax dollars be spent to purchase products and services made in Colorado and the United States (HB 1129) and curb the harmful impacts of outsourcing jobs overseas (SB 185). While the legislation to achieve these goals died in the GOP-controlled House, we know that these ideas are very popular with the general public. We will continue to advance them through legislation until we have a legislature that will support our domestic economy and jobs here at home.

The "Reinvest in Colorado" agenda also called for supporting budget policies that protect critical services for the public and respect the valuable public servants that provide them. While the budget could have been much worse, the economic and constitutional constraints impacting our state budget still required massive cuts to public schools and critical services. Public employees still face tremendous challenges in the form of wage freezes, increases in their pension contributions and higher healthcare costs. We must begin to have significant public discourse of all efforts to stabilize our state's fiscal future – including asking voters to consider raising additional revenue to make investments in our state's infrastructure.

Finally, we challenged legislators and the Governor to work with us collaboratively to find solutions to get people back to work and make sure those who are unemployed have the resources they need until they find a job. The split control of the legislature required that all parties work together to achieve success. We are particularly proud of HB 1115 (Public Entity Construction Retainage) which will help both contractors and trades professionals in a very tough economy. HB 1288 (Unemployment Insurance Solvency Reform) will stabilize our UI Trust Fund and provide insurance premium relief to employers without a reduction of benefits for those without work. Both bills are great examples of a bi-partisan coalition of legislators and stakeholders working together for the good of our state. We were pleased to be part of those efforts.



Goals and General Analysis of Scorecard

We are proud to share the 2011 Colorado AFL-CIO Working Families Scorecard with the general public to educate them on where their state legislators stand on issues of importance to Colorado's working families. In previous years, the Colorado AFL-CIO has tracked legislation exclusively to educate our affiliate unions and their members, but we believe that it's important for the public to have this information.

Overall, we expected to play a lot of defense in 2011 and we believe we successfully defended the interests of our members and affiliates with the help of strong support from Democratic legislators. We are pleased that 17 of 20 Senate Democrats and 20 of 32 House Democrats chose to support our position 100% of the time when they had an opportunity to record a vote on a bill we tracked. Additionally, we worked as part of strong, bi-partisan coalitions to achieve success on a number of issues. Because of this we achieved a marked increase in voting scores from GOP legislators in 2011 and built some stronger ties across party lines. Of the 35 pieces of legislation we advocated for or against, the final outcome of the legislation matched the Colorado AFL-CIO position 72% of the time.

Tracking & Vote Scoring Procedures

All 701 pieces of legislation filed in 2011 were reviewed by the Colorado AFL-CIO and/or local affiliates unions to determine their impact on our members and Colorado working families. In consultation with our affiliates and Executive Council we determined positions of "Support", "Oppose" or "Monitor" on bills of interest. In 2011, we tracked 54 floor and committee votes on bills and amendments related to 35 pieces of legislation. We weighted the floor and committee votes equally and did not penalize legislators who did not vote on a legislation in committee or were excused absences for floor votes. We used this formula to determine the final 2011 "score":

of cast votes consistent with AFL-CIO position / Total # of possible votes legislator had on tracked bills = Score %

Additionally, legislators with multiple sessions of legislative service had their 2011 score averaged with previous years scores to calculate a "lifetime score."
