On Thursday, April 12, 2012 I, Corporal Macchione was on patrol and working in Grand County, Colorado. I was wearing full department issued uniform and driving a fully marked patrol vehicle (unit 1122).

At approximately 1500 hours, I was on duty and I learned of a male party identified as Frierson, Micheal K. DOB: 12-12-79 who had an active warrant for his arrest out of the Grand County Sheriffs Department for 18-3-412.5 Failure to register as a sex offender. I learned that the most recent address for Frierson was at 124 Ridgeway Avenue in Hot Sulphur Springs, Colorado 80451.

I arrived at the residence at approximately 1606 hours. Upon my arrival I observed a male party in the driveway cleaning out a car. I observed that male party to be Frierson. I knew Frierson from 2009 when I worked in the Grand County Jail. I proceeded to run Frierson through Grand County Dispatch and I learned that the arrest warrant was still active. I informed Frierson to turn around and to place his hands behind his back. Frierson complied with my instructions. I placed Frierson into hand cuffs. I checked the handcuffs for proper fit and double locked them. I then placed Frierson into the back seat of my patrol vehicle and placed his seat belt on him. Frierson was then transported to the Grand County Jail without incident where he was booked on warrant DO252012CR000026 18-3-412.5 failed to register as a sex offender.



On March 12, 2012, I spoke to Investigator Peschiera and she asked me to review a sex offender registry file that was in her in box and asked if I would draft up an arrest warrant for the individual listed in the file.

I retrieved the sex offender registry file and reviewed the information. The file was for Frierson, Michael (DOB: 12/12/79) a convicted sex offender that had failed to re-register on 12/12/11. As of 03/20/12, I am still in the process of issuing an arrest warrant for Frierson for CRS 18-3-412.5(1)(a) Failure to Register as a sex offender, a class 6 Felony and CRS 18-3-412.5(1)(g) Failure to notify Law Enforcement for a change of address, a class 6 Felony as amended.

On March 22, 2012, I Deputy Sprague applied for an warrant for the arrest of Frierson, Michael for the above listed offenses. DA Elizabeth Oldham from the 14th Judicial District approved the arrest warrant and Judge Hoak from the 14th Judicial District signed off on the warrant. ATTACHMENT A

On March 13, 2012, Your affiant, Deputy Sprague, hereinafter referred to as I or me, was in full uniform working the Patrol Division for the Grand County Sheriff's Office in Grand County Colorado, driving marked unit 114. I was told by Investigator Peschiera of the Grand County Sheriff's Office that a previously registered sex offender had failed to register on his birthday as required by CRS 16-22-108(b) and had failed to register that he had changed his address. Investigator Peschiera provided me the sex offender registry file (maintained at the Grand County Sheriff's Office) identifying the previously registered sex offender as Michael K. Frierson, Date of birth 12/12/79.

Through my investigation and review of the sex offender file, I learned the following information:

- The information provided and stated on multiple sex offender registration forms maintained and completed by the Grand County Sheriff's Office identifies the sex offender as Michael K. Frierson, Date of birth: 12/12/79 [REDACTED] and Colorado Driver's License #: 96-211-0362.
- Frierson is described as a white male, standing 6'0" in height, weighing 170 lbs, having brown hair and blue eyes. This information was obtained from Frierson's Sex Offender Registry file, completed and maintained by the Grand County Sheriff's Office in Grand County Colorado.
- On 10/11/11, Corporal Austin completed a Sex Offender address verification form for Frierson. It was found that Frierson no longer lived at 300 Range St., Kremmling, CO 80459 per the current resident. Frierson had not notified the Grand County Sheriff's Office that he had moved and what his current address was.
- On 12/12/11, Frierson was due to come into the Sheriff's Office to register on his birthday as required by CRS 16-22-108(b). Frierson did not come in on that date to register.
- Frierson was called by Carolyn Motz, an employee of the Grand County Sheriff's Office on 12/22/11. Frierson stated he was in Denver at the time. Frierson was asked what his address was and he said he was living in Hot Sulphur Springs, CO 80451 with a friend and was unsure of the address.
- Frierson was informed by Carolyn Motz that he was required to register and was asked when he would be at the Sheriff's Office to do so.
- Frierson said he would be in to register on 12/27/11. Frierson did not show up to register and did not call.
- Frierson was again called by Carolyn Motz on 12/29/11. A voicemail was left on Frierson's phone and he did not return the phone call or come in to register.
- Carolyn Motz called Frierson on 12/30/11, informing him that he had until 01/05/12 to come in to register or a warrant would be issued for his arrest.
- As of 03/13/12, Frierson has not come to the Sheriff's Office to register or to notify law enforcement of his change of address.

On 03/19/12, Corporal Austin of the Grand County Sheriff's Office called and informed me of the following information in regards to Frierson. Corporal Austin said on 03/18/12, Investigator Peschiera of the Grand County Sheriff's Office, gave him a Sex Offender address verification form to verify if Frierson was still living at his last known address of 300 Range St., Kremmling, CO 80459 (obtained from Frierson's Sex Offender Registry file). Corporal Austin told me he spoke to George Lee, the resident of the above address and Frierson's grandfather. Corporal Austin stated that Lee told him Frierson had not lived at the residence for approximately one year. Lee stated to Corporal Austin that he did not know where Frierson was currently residing. Corporal Austin said he completed the address verification form and gave it back to Investigator Peschiera to be put in Frierson's Sex Offender Registry file.

On 03/20/12, I told Corporal Austin that as of 12/20/10, Frierson's last known place of employment as listed in his Sex Offender Registry file was at Rocky Mountain Timber (unknown address or phone number located on Hwy. 9 near the Pellet plant) Kremmling, CO 80459. I asked Corporal Austin to check and see if Frierson was still working at Rocky Mountain Timber in Kremmling, CO. On 03/20/12, Corporal Austin checked at Rocky Mountain Timber to see if Frierson was still employed at the business. Corporal Austin told me that no one was on the premises and that it appeared to not be operating at this time.
